**Background:**

Himachal Pradesh State Biodiversity Board organised one day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004, with focus on its Access and Benefit Sharing (ABS) Provisions on 22<sup>nd</sup> June 2016 at Dev Sadan, Dhalpur, Kullu, District Kullu, Himachal Pradesh for the stakeholders namely; Zila Parishad Members, Panchayat Samiti Members, all Panchayat Pradhans of District Kullu and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda Departments, G.B. Pant National Institute of Himalayan Environment & Sustainable Development, Mohal-Kullu, Non-Government Organizations (NGOs) and officers from District administration of Kullu District. The Training workshop was organized for increasing understanding and awareness about importance of biodiversity, role and issues concerning biodiversity conservation and sustainable use of bio-resources and Biological Diversity Act, 2002 and Rules, 2004, diversity of Medicinal plants in Himachal Pradesh, Biodiversity of Himachal Pradesh, Constitution of Biodiversity Management Committees (BMCs) at local body level, their role and duties, preparation of People's Biodiversity Registers and Access and Benefit Sharing (ABS) provisions of Biological Diversity Act .

One day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004, with focus on its Access and Benefit Sharing (ABS) Provisions was organised as per the technical schedule (Annexure-I) .

**Inaugural Session**

Before the start of the workshop, the participants namely: Zila Parishad Members, Panchayat Samiti Members, Non-Government Organizations, Panchayat Pradhans of district Kullu and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda, G.B. Pant National Institute of Himalayan Environment & Sustainable Development, Mohal-Kullu and Non-Government Organizations were registered from 10.00 am to 10.30 am by the H.P. State Biodiversity Board at Dev Sadan, Dhalpur, Kullu.

Himachal Pradesh State Biodiversity Board organized the One day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004, with focus on its Access and Benefit Sharing (ABS) Provisions in collaboration with Forest Department, District Kullu, H.P in which about 375 stakeholders namely; Zila Parishad members, Panchayat Samiti Members, Non-Government

Organizations, Panchayat Pradhans of district Kullu and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda, G. B. Pant National Institute of Himalayan Environment & Sustainable Development, Mohal-Kullu and Non-Government Organizations were present. Newly elected members of 168 Gram Panchayats, 8 Zila Parishad and 65 Block Samiti of District Kullu attended the workshop. The list of participants has been enclosed at Annexure-II. The function started by lighting of the Lamp by Chief Guest Sh. Hans Raj Chauhan, Deputy Commissioner, District Kullu, Himachal Pradesh at Dev Sadan, Kullu. Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board welcomed the participants and other dignitaries on the Dias and other participating stakeholders of biodiversity viz. Zila Parishad Members, Panchayat Pradhans, Non-Government Organizations, of district Kullu and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda, G.B. Pant National Institute of Himalayan Environment & Sustainable Development, Mohal-Kullu and Non-Government Organizations.

Sh. Kunal Satyarthi briefed the participating stakeholders about the historical background and purpose of organising One day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004, with focus on its Access and Benefit Sharing (ABS) Provisions. He informed the participants that in current financial year Himachal Pradesh State Biodiversity Board has selected four Districts namely; Sirmaur, Kullu, Chamba and Shimla for organising such type of one day training workshops. One training workshop has already been organised in District Sirmaur on 22<sup>nd</sup> May, 2016 on the occasion of International Day for Biological Diversity (IBD). Mr. Satyarthi told the participants that purpose of this one day training workshop is to make the participants aware about the importance of Biodiversity, Biological Biodiversity Act, 2002 and Rules 2004, Biodiversity of Himachal Pradesh, Diversity of Medicinal Plants of Himachal Pradesh, Constitution of Biodiversity Management Committees (BMCs), role and responsibilities of BMCs in implementation of Biological Biodiversity Act, 2002 and Rules, 2004, Preparation of People's Biodiversity Registers (PBRs) and to make participants aware about Access and Benefit Sharing (ABS) provisions of Biological Diversity Act.

Sh. Ajay Kumar Lal, Director, Department of Environment, Science and Technology, H.P -cum- Member Secretary, H.P. State Biodiversity Board briefed the participants about the activities of the Himachal Pradesh State Biodiversity Board (HPSBB) and various steps being taken up by HPSBB for implementation of the Biological Diversity Act, 2002 in the State.

Sh. B.L. Negi, Conservator of Forests, Kullu Circle in his special address made participants aware about important provisions of Biological Diversity Act, 2002 and its importance in conservation and sustainable use of precious biological Resources of the State. He thanked the H.P. State Biodiversity Board for organising one day training workshop in Kullu District.

Sh. Hans Raj Chauhan, Deputy Commissioner, Kullu in his inaugural address highlighted about the importance of biodiversity in our day to day life and the necessity of making people aware about the Biological Diversity Act, 2002 provisions at every local body level in the District Kullu. He exhorted participants to form Biodiversity management Committees (BMCs) at each local body level in the District and to take active participation in formation of People's Biodiversity Registers (PBRs) for documentation of floral and faunal biodiversity as well as documentation of Indigenous Technical Knowledge (ITK) associated with the use of biological resources.

The Chief Guest Sh. Hans Raj Chauhan, Deputy Commissioner, Kullu, released the “***Guideline Manual for Constitution of Biodiversity Management Committees***” published by Himachal Pradesh State biodiversity Board.

After the inaugural addresses a Skit on “***Importance of biodiversity conservation and protection***” was performed by the students of Govt. Senior Secondary School, Bajaura, Distt, Kullu, Himachal Pradesh.

Dr. Neeraj Chadha, Divisional Forest Officer, Kullu, District Kullu thanked Himachal Pradesh State Biodiversity Board for organising one day training workshop in District Kullu and the Chief Guest, all the participants for participation in the training workshop.

### **Technical Session-I**

After tea break Dr. D. R. Naag, Ex-In-charge, Herbal Garden, Jogindernagar, District Mandi, Himachal Pradesh delivered presentation on “Diversity of Medicinal Plants in Himachal Pradesh”. In his presentation, he highlighted important medicinal plants of Himachal Pradesh, their economic value, distribution range of different medicinal plants in the State, methods for propagating these economically important medicinal plants and their potential as livelihood option in current scenario in the state of Himachal Pradesh.

Sh. Ajay Kumar Lal, Director, Department of Environment, Science and Technology, H.P-cum-Member Secretary, H.P. State Biodiversity Board delivered lecture to the stakeholders about biodiversity, importance of biodiversity status, threats/issues, sustainable use with special reference to the valuable bioresources conservation needs in the State of Himachal Pradesh in general and Kullu District in particular .

Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board delivered lecture and gave presentation to the participating stakeholders about the provisions of Biological Diversity Act, 2002 and Rules, 2004 with special focus on Access and Benefits Sharing (ABS) accruing out of the use of biological resources and traditional knowledge based on local bioresources. He said that Biodiversity Management Committees (BMCs) are to be constituted in all Panchayats of Himachal Pradesh with the aim to empower the stakeholders for management of biodiversity at local body level in the District.

## Technical Session-II

After lunch break Dr. S.S. Samant, Scientist In-charge, G.B. Pant National Institute of Himalayan Environment and Sustainable Development (GBPNIHESD), Mohal-Kullu, Distt. Kullu, Himachal Pradesh made participants aware about biodiversity of Himachal Pradesh. He briefed participants about the different research programmes and findings of GBPNIHESD, Mohal-Kullu especially in economical valuable floristic diversity of Himachal Pradesh with special focus on biodiversity of Kullu District.

Dr. Pankaj Sharma, Sr. Scientific professional, Himachal Pradesh State Biodiversity Board in his presentation made the participants aware about constitution of Biodiversity Management Committees (BMCs) under Section 41(1) of the Biological Diversity Act, 2002 at Local Body level, their role in implementation of Biological Diversity Act, 2002. He discussed in detail regarding the procedure adopted for constitution of BMCs and way of filling the Proforma/Format used for constitution of Biodiversity Management Committees (BMCs) at Panchayat level.

Dr. Dushyant Sharma, Scientific Professionals, Himachal Pradesh State Biodiversity Board deliberated regarding People's Biodiversity Registers (PBRs) preparation and elaborated how to fill up the requisite information in the format and Annexures for preparation of PBRs at Panchayat level by the BMCs. He informed that PBR will not only contain data on flora and fauna of the Panchayat but would also document information on Peoplescape, Landscape, Sacred groves, Biodiversity hotspots, Rituals and Indigenous Technical Knowledge (ITK) of the local people about local bio-resources.

Thereafter, General discussions were held regarding inputs from stakeholders by way of Questions and Answers. The target for constitution of Biodiversity Management Committees (BMCs) at the Panchayats of Kullu District was fixed upto 31<sup>st</sup> July, 2016. The training workshop ended with discussion and planning for future action which was done under the guidance and supervision of Sh. Kunal Satyarthi, Joint Member Secretary and Sh. K. Kaisth, Principal Scientific Officer, Himachal Pradesh State Biodiversity Board. It was decided that in the coming Gram Sabha of the Panchayats on 10<sup>th</sup> July, 2016, Biodiversity Management Committees (BMCs) will be constituted in all the participating Panchayats by the Panchayat Pradhans and thereafter, capacity building programmes for Biodiversity Management

Committees (BMC) and Technical Support Group (TSG) members for preparation of People's Biodiversity Registers (PBRs) will be organised at Block level in District Kullu. The one day workshop ended with a vote of thanks by Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board.
