Background:

International Biodiversity Day is celebrated every year on 22nd May for increasing understanding and awareness about the importance, role and issues concerning biodiversity amongst the stakeholders of biodiversity from different walks of life and conservation and sustainable use of biological diversity on the earth.

Himachal Pradesh State Biodiversity Board organizes International Biodiversity Day every year in the State ever since its constitution and establishment by the Govt. of H.P in the State Council for Science Technology and Environment, H.P. The theme for International Biological Diversity Day for 2016 was "Mainstreaming Biodiversity; Sustaining People and their Livelihoods".

This year the International Biodiversity Day was celebrated by The H.P. State Biodiversity Board by organising one day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004, constitution of Biodiversity Management Committees, preparation of Peoples Biodiversity Registers (PBRs) on 22nd May 2016 at SFDA Hall at Nahan, District Sirmaur, Himachal Pradesh for the stakeholders namely; Zila Parishad Members, Panchayat Samiti Members, all Panchayat Pradhans of District Sirmaur and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda Departments and officers from District administration of Nahan District as per the directions from National Biodiversity Authority, GoI, at Chennai. The Training workshop was organized for increasing understanding and awareness about importance of biodiversity, role and issues concerning biodiversity conservation and sustainable use of bio-resources and Biological Diversity Act,2002 and Biological Diversity Rules, 2004, Constitution of Biodiversity Management Committees at local body level, their role and duties and preparation of People's Biodiversity Registers.

One day training workshop on Biological Biodiversity Act, 2002 and Rules, 2004 to the participating stakeholders was organised as per the technical schedule (Annexure-I) prepared by the H.P.State Biodiversity Board for celebration of International Biodiversity Day on 22nd May 2015.

Inaugural Session

Before the start of the State Level function for celebration of International Biodiversity Day, 2016 the stakeholders namely: Zila Parishad members, Panchayat Samiti Members, Non Government Organizations, Panchayat Pradhans of district Sirmaur and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda and Non-Government Organizations were registered from 9.30 am to 10.30 am by the H.P. State Biodiversity Board at SFDA Hall, Nahan.

Himachal Pradesh State Biodiversity Board organized the one day Training Workshop on Biological Biodiversity Act, 2002 and Rules, 2004 in collaboration with Forest Department, District Sirmaur, H.P in which about 350 stakeholders namely; Zila Parishad members, Panchayat Samiti Members, Non Government Organizations, Panchayat Pradhans of district Sirmaur and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda and Non Government Organizations were present. Out of 240 Panchayats of district Sirmaur, representatives of 206 Panchayats attended the workshop. The list of participants has been enclosed at Annexure-II. The function started by lighting of the Lamp by Chief Guest Sh. Baldev Singh, Hon'ble District and Sessions Judge, District Sirmaur Himachal Pradesh at Nahan. Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board welcomed the participants and other dignitaries on the Dias and other participating stakeholders of biodiversity viz. Zila Parishad members, Panchayat Pradhans, Non Government Organizations, of district Sirmaur and officials from Forest, Agriculture, Horticulture, Education, Animal Husbandry, Ayurveda and Non Government Organizations.

Sh. Kunal Satyarthi briefed the participating stakeholders about the historical background and purpose of celebration of International Biodiversity Day on 22 May every year. He further informed the participants that the H.P State Biodiversity Board is celebrating the International Biodiversity Day by organising one day training workshop to make the participants aware about the importance of Biodiversity, Biological Biodiversity Act,2002 and Rules, 2004, Constitution of Biodiversity Management Committees (BMCs), role and responsibilities of BMCs in implementation of Biological Biodiversity Act, 2002 and Rules, 2004 and Preparation of People's Biodiversity Registers (PBRs).

Sh. Ajay Kumar Lal, Director, Environment, Science and Technology, H.P-cum-Member Secretary, H.P State Biodiversity Board gave special remarks about the one day Training workshop. He briefed the participants about the activities of the H.P State Biodiversity Board taken up for implementation of the Biological Diversity Act, 2002 in the State.

Hon'able District and Sessions Judge, Sh. Baldev Singh in his inaugural address highlighted about the importance of biodiversity in ancient scriptures and the importance of awareness about the Biological Diversity Act, 2002 provisions among Panchayat representatives, departments and other agencies working at the grassroot level and sharing the benefits accruing out of the use of biological resources and traditional knowledge based on local bio-resources at the local body level as per the provisions enshrined in the Biological Diversity Act, 2002 & Rules, 2004 for prosperity and posterity of the state. He appreciated the activities of the H.P. State Biodiversity Board

A special address was delivered by Sh.Y.P. Gupta, Conservator of Forests, Nahan Circle. He thanked the Himachal Pradesh State Biodiversity Board for organizing one day Training workshop in collaboration with Forest Department at District Sirmaur. He asked the participants

for taking active role in conservation and sustainable use of the bio-resources at local body level in close association with line departments especially with Forest Department for the prosperity and posterity of Sirmaur District and also for conservation of natural ecosystems.

Sh. Harbans Singh Brascon, Additional District Magistrate Nahan in his special address appreciated the role of HP State Biodiversity and for the selecting District Sirmaur, District for celebration of the International Biodiversity Day and implementation of BD Act, 2002 in District Sirmaur and assured about full cooperation of the officials of Sirmaur District.

After the inaugural addresses a Skit on "Biodiversity and Man" was performed for highlighting the importance and conservation needs by the students of Govt. Senior Secondary School, Moginand, Distt, Sirmaur, H.P.

Sh. Nishant Mandhotra, Divisional Forest Officer Nahan, District Sirmaur thanked The Chief Guest, all the participants, distinguished guests and officials of Forest department and all the representatives of PRIs and officials of Himachal Pradesh State Biodiversity Board for participation in the training workshop.

Technical Session-I

After the tea break Technical Sessions were held. Sh. Ajay Kumar Lal, Director, Environment, Science and Technology, H.P-cum-Member Secretary, H.P. State Biodiversity Board delivered lecture to the stakeholders about biodiversity, importance of biodiversity status, threats/issues, sustainable use with special reference to the valuable bioresources conservation needs in the State of Himachal Pradesh in general and Sirmaur District in particular.

Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board delivered lecture and gave presentation to the participating stakeholders about the provisions of Biological Diversity Act, 2002 and Biological Diversity Rules,2004 with special focus on Access and Benefits sharing (ABS) accruing out of the use of biological resources and traditional knowledge based on local bioresources. He said that Biodiversity Management Committees (BMCs) are to be constituted in all Panchayats of Himachal Pradesh with the aim to empower the stakeholders for management of biodiversity at local body level in the Districts.

Technical Session-II

Dr. Pankaj Sharma, Senior Scientific professional, Himachal Pradesh State Biodiversity Board in his presentation made the participants aware about constitution of Biodiversity Management Committees (BMCs) under Section 41(1) of the Biological Diversity Act, 2002 at Local Body level, their role in implementation of Biological Diversity Act, 2002.He discussed in detail regarding the procedure adopted for constitution of BMCs and way of filling the Proforma/Format used for constitution of Biodiversity Management Committees (BMCs) at Panchayat level.

Dr. Dushyant Sharma, Scientific Professionals, Himachal Pradesh State Biodiversity Board deliberated regarding People's Biodiversity Registers (PBRs) preparation and elaborated how to fill up the requisite information in the format and Annexures for preparation of PBRs at Panchayat level by the BMCs. He informed that PBR will not only contain data on flora and fauna of the Panchayat but would also document information on Peoplescape, Landscape, Sacred groves, Biodiversity hotspots, Rituals and Indigenous Technical Knowledge (ITK) of the local people about local bio-resources.

Thereafter, General discussions were held regarding inputs from stakeholders by way of Questions and Answers. The target for constitution of Biodiversity Management Committees at the Panchayats of Sirmaur District was fixed upto 1st July, 2016. The training workshop ended with discussion and planning for future action which was done under the guidance and supervision of Sh. Kunal Satyarthi, Joint Member Secretary and Sh. K. Kaisth, Principal Scientific Officer, Himachal Pradesh State Biodiversity Board. It was decided that in the coming Gram Sabha of the Panchayats on 1st July, 2016, Biodiversity Management Committees will be constituted in all the participating Panchayats by the Panchayat Pradhans and thereafter, capacity building programmes for Biodiversity Management Committees (BMC) and Technical Support Group (TSG) members for preparation of People's Biodiversity Registers (PBRs) will be organised at Block level in District Sirmaur. The one day workshop ended with a vote of thanks by Sh. Kunal Satyarthi, Joint Member Secretary, Himachal Pradesh State Biodiversity Board.

Biodiversity board to rein in private drug-making firms

SHIMLA, MAY 22

After giving them a free run for about 14 years, the HP State Biodiversity Board (HPSBB) has decided to rein in private companies that have been making drugs, herbal and other products by misusing bio-resources.

These companies will now have to pay about two per cent of their share to the panchayat-based biodiversity management committee (BMC) under the Biological Diversity (BD) Act, 2002.

The neighbouring Uttarakhand has already prepared the Peoples Biodiversity Registers (PBRs) documenting its biological resources but Himachal has woken up to implement the Biological Diversity Act after 14 years.

The Act is being implemented on a pilot basis in Shimla, Sirmaur, Kullu and Chamba districts.

"The PBR will document lions of rupees every year. each traditional crop like 'lal chawal' and 'kodra', both traditional pahari grains and other bioresources available in the panchayat area. Once documented, farmers can patent them as well," said Kunal Satyarthi, member secretary, HPSBB.

The board organised a training workshop involving NGOs, government departments, panchayat and zila parishad members of Sirmaur district at Nahan to sensitise people on the Act, he added.

"We will constitute BMCs in all districts. The idea is to empower the sources of livelihoods of villagers," Satyarthi said.

Though nobody knows the exact dimension of the bio-business that flourishes on biological resources of the state, the experts suspect it runs into several mil-

As of now, the Himachal Government has been giving a free hand to the private bio-business compaand individuals engaged in herbal and bioresources businesses.

The panchayat-based BMCs would ensure the implementation of the Biological Diversity Act and help prepare the PBRs, said Dr Pankaj Sharma, a scientist.

Ajay K Lal, director, Environment, Science and Technology, who is also the member secretary of the HPSBB, said the Act had been implemented in the state and BMCs would be formed in each district.

District and Sessions Judge, Nahan, Baldev Singh, said, "The Biodiversity Act needs to be implemented for conservation and sustainable use, sharing its benefits and traditional knowledge at the local level."
