OFFICE MEMORANDUM

Subject:

Licenses of traders and manufacturers involved in trade and/or utilization of Himachal based biological resources NOT to be renewed without NoC from the HP State Biodiversity Board.

The Biological Diversity Act, 2002, provides for conservation of Biological Diversity, sustainable use of its components and fair and equitable sharing of the benefits arising out of the use of biological resources, knowledge and for matters connected therewith or incidental thereto. The said Act and related instruments, especially Section 7, provides for submission of prior intimation by the Traders and Manufacturers to the State Biodiversity Board concerned. Further, Rule 11 (19) of the Himachal Pradesh Biological Diversity Rules, 2019, empowers the State Biodiversity Board to prohibit or restrict any activity which is detrimental or contrary to the objectives of conservation and sustainable use of biodiversity or equitable sharing of benefits arising out of such activities.

Despite a number of directions, it has been reported that most of the traders and manufacturers involved in trade and/or utilization of Himachal based biological resources are not doing compliance as per provisions of the Biological Diversity Act, 2002, therefore, in pursuance to the Section 23 of the Biological Diversity Act, 2002 and Rule 11 (19) of the Himachal Pradesh Biological Diversity Rules, 2019, it has been decided that the licenses of traders and manufacturers involved in trade and/or utilization of Himachal based biological resources by the concerned licensing authorities are NOT to be renewed without NoC from the Himachal Pradesh State Biodiversity Board. These NoCs would be issued by the Himachal Pradesh State Biodiversity Board to these traders and/or manufacturers on their registration with the Biodiversity Board.
